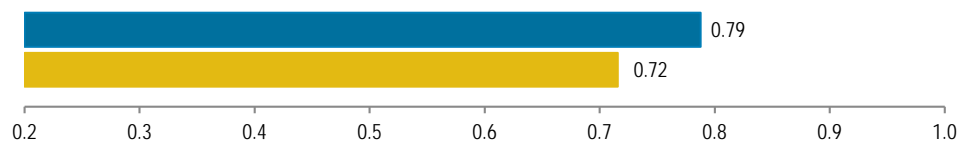

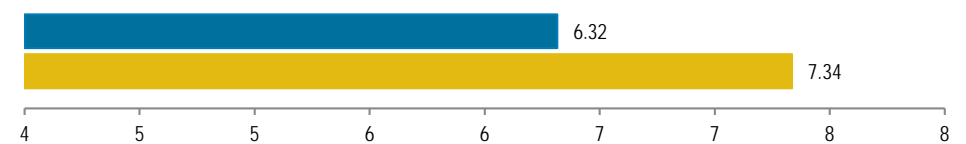

**Historical Risk Profile** as of 03/31/18

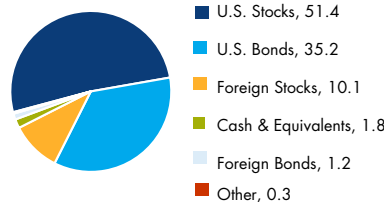
**Sharpe Ratio<sup>4</sup> - 3 year**



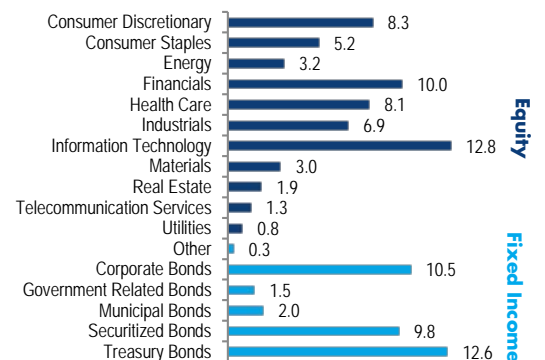
**Standard Deviation<sup>5</sup> - 3 year**

On December 12, 2016, the Pax Balanced Fund converted to a fund of funds asset allocation structure. The Fund continues to have the same investment objective, portfolio management team, strategic asset allocation and expenses; however, now the Fund's asset allocation components are fully invested in Pax World Funds rather than a combination of individual securities and mutual funds.

<sup>1</sup>Weighted Average is an average in which each quantity to be averaged is assigned a weight. These weightings determine the relative importance of each quantity on the average.

<sup>2</sup>Duration is a measure of a security's price sensitivity to changes in interest rates. Securities with longer durations are more sensitive to changes in interest rates than securities of shorter durations.

<sup>3</sup>Years to Maturity (weighted average) is the number of years until the bond matures and/or expires.

<sup>4</sup>Sharpe ratio determines a risk-adjusted return using standard deviation; a high Sharpe ratio indicates greater return per unit of risk and demonstrates if performance was based on smart investments or on excess risk.

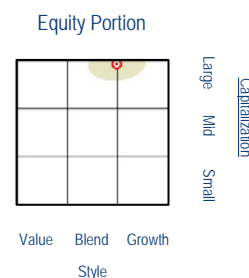

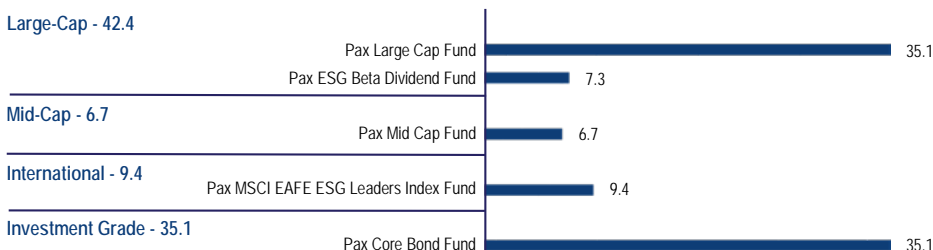

<sup>5</sup>The Morningstar style box is a nine-square grid that classifies securities by size along the vertical axis and by style (value and growth characteristics) along the horizontal axis. Morningstar's equity style methodology uses a building block, holdings-based approach. Funds are classified as large, mid, or small based on the market capitalization of its portfolio holdings. Style is determined at the stock level and then those attributes are rolled up to determine the overall investment style of a fund.

<sup>6</sup>Figures include reinvested dividends, capital gains distributions, and changes in principal value.

<sup>†</sup>Inception of Institutional Class shares is April 2, 2007. The performance information shown for Institutional Class shares represents the performance of the Individual Investor Class shares for the period prior to Institutional Class inception. These portfolios tend to hold larger positions in stocks than conservative-allocation portfolios. These portfolios typically have 50% to 70% of assets in equities and the remainder in fixed income and cash.

<sup>5</sup>Standard Deviation measures a fund's variation around its mean performance; a high standard deviation implies greater volatility.

<sup>6</sup>Beta reflects the sensitivity of a fund's return to fluctuations in its benchmark; a beta for a benchmark is 1.00: a beta greater than 1.00 indicates above average volatility and risk.

<sup>7</sup>Alpha is a coefficient measuring risk-adjusted performance, considering the risk due to the specific security, rather than the overall market. A positive alpha reflects relative risk-adjusted performance of a fund versus its benchmark.

<sup>8</sup>R-Squared is a measure of how much a portfolio's performance can be explained by the returns from the overall market (or a benchmark index).

<sup>f</sup>The Lipper Mixed-Asset Target Allocation Growth Funds Index ("Ind") tracks the results of the 30 largest mutual funds in the Lipper Mixed-Asset Target Allocation Growth Funds Average. The Lipper Mixed-Asset Target Allocation Growth Funds Average ("Avg") is a total return performance average of mutual funds tracked by Lipper, Inc. whose primary objective is to conserve principal by maintaining, at all times a mix of between 60%-80% equity securities, with the remainder invested in bonds, cash, and cash equivalents. The Lipper Mixed-Asset Target Allocation Growth Funds Index is not what is typically considered to be an "index" because it tracks the performance of other mutual funds rather than changes in the value of a group of securities, a securities index or some other traditional economic indicator.
